**TRUSTEES' REPORT
FOR THE YEAR ENDED 31 AUGUST 2022**

The Trustees present their annual report together with the financial statements and auditors' report of the Charitable Company for the year ended 31 August 2022. The annual report serves the purpose of both a Trustees' report, and a Directors' report under company law.

The Trust operates 5 primary schools for pupils aged 2 to 11 in Beaford, Brayford, High Bickington C of E, UMBERLEIGH and WITHERIDGE C of E and 1 junior school for pupils aged 7-11 in Pilton Bluecoat C of E. It has a combined pupil capacity of 702 and had a roll of 606 in the school census on January 2022.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Constitution

The Academy Trust is a company limited by guarantee and an exempt charity. The Charitable Company's Memorandum and Articles of Association are the primary governing documents of the Academy Trust. The Trustees of TEAM Multi-academy Trust are also the directors of the Charitable Company for the purposes of company law. The Charitable Company operates as TEAM Multi-academy Trust.

Details of the Trustees who served throughout the year, and to the date the accounts are approved are included in the Reference and Administration Details.

Trustees' Liability

Each Trustee of the Charitable Company undertakes to contribute to the assets of the Company in the event of it being wound up while he/she is a Trustee, or within one year after he/she ceases to be a Trustee, such amount as may be required, not exceeding £10, for the debts and liabilities contracted before they cease to be a Trustee.

Trustees' Indemnities

Trustees benefit from indemnity insurance purchased at the Academy Trust's expense to cover the liability of the Trustees which by virtue of any rule of law would otherwise attach to them in respect of any negligence, default or breach of trust or breach of duty of which they may be guilty in relation to the Academy Trust, provided that any such insurance shall not extend to any claim arising from any act or omission which the Trustees knew to be a breach of trust or breach of duty or which was committed by the Trustees in reckless disregard to whether it was a breach of trust or breach of duty or not and provided also that any such insurance shall not extend to the costs of any unsuccessful defence to a criminal prosecution brought against the Trustees in their capacity as Directors of the Academy Trust. The limit of this indemnity is £5,000,000 on any one claim.

Method of recruitment and appointment or election of Trustees

The Academy's Board of Trustees comprises the Chief Executive Officer and up to 14 other Trustees.

The Academy Trust shall have the following Trustees as set out in its Articles of Association and funding agreement:

- 8 foundation Trustees – nominated by the PCC and appointed by the Foundation Members
- 6 Non Foundation Trustees – appointed through such process as the Trustees determine
- the Chief Executive Officer who is treated for all purposes as being an ex officio Trustee.

Trustees are appointed for a four-year period, except that this time limit does not apply to the Chief Executive Officer. Subject to remaining eligible to be a particular type of Trustee, any Trustee can be re-appointed or re-elected.

When appointing new Trustees, the Board will give consideration to the skills and experience mix of existing Trustees in order to ensure that the Board has the necessary skills to contribute fully to the Academy's development.

In addition to the above Trustees, there are 5 Local Governing bodies (LGB) representing the school communities. One LGB representing Pilton, one representing High Bickington, one representing Witheridge, one representing Beaford and one representing Brayford and Umberleigh combined. The makeup of each LGB is as follows:

- The chair of each LGB, with the exception of Pilton Bluecoat and Beaford, is a Trustee who reports back to the main board of Trustees
- At least 2 co-opted parent committee members
- At least 1 co-opted staff member from each school

Policies and Procedures adopted for the Induction and Training of Trustees

The training and induction provided for new Trustees will depend upon their existing experience but would always include a tour of the Academy and a chance to meet staff and pupils. All Trustees are provided with copies of policies, procedures, minutes, accounts, budgets, plans and other documents that they will need to undertake their role as Trustees. As there are normally only one or two new Trustees a year, induction tends to be done informally and is tailored specifically to the individual. Advantage is taken of specific courses offered by the Local Authority and other bodies.

The development of the Trust online platform, BlueSky, for CPD and Performance Management provides Trustees with the opportunity for self-assessment themselves against the NGA standards. Outcomes from the NGA audit is used by leaders to complete a needs analysis and plan training activities. Governor training opportunities are uploaded regularly onto the platform so that they can engage in development throughout the year.

Organisational Structure

The Board of Trustees normally meets once each term. The Board establishes an overall framework for the governance of the Academy and determines membership, terms of reference and procedures of Committees and other groups. It receives reports including policies from its committees for ratification. It monitors the activities of the Committees through the minutes of their meetings. The Board may from time to time establish Working Groups to perform specific tasks over a limited timescale.

There are 5 committees as follows:

- Audit and Finance Committee - this meets at least four times a year and is responsible for monitoring, evaluating and reviewing policy and performance in relation to financial management, compliance with reporting and regulatory requirements and reporting, receiving reports from the internal audit and drafting the annual budget including setting staffing levels. It also incorporates the role of an audit committee.
- Scrutiny and Standards Committee - this meets once a term to monitor, evaluate and review Academy policy, practice, and performance in relation to curriculum planning, communications, target setting and assessment, examinations and all pastoral issues.
- Admissions Committee which meets when necessary to deal with all matters relating to admissions.
- Premises Committee – this meets termly to monitor the Trust's estate for works required and health and safety concerns.
- Personnel Committee – this meets termly to discuss staff changes and to advise on pay related matters.

The following areas are reviewed and discussed at LGB level and recommendations, and reports are returned to the whole board of Trustees: local school issues particularly related to the curriculum, SEN provision, pupil welfare, early year's provision and promotion of strong community links. The list of delegation has been overhauled and is now in operation.

The following decisions are reserved to the Board of Trustees: to consider any proposals for changes to the status or constitution of the Academy and its committee structure, to appoint or remove the Chairman and/or

Vice Chairman, to appoint the Chief Executive Officer and Clerk to the Trustees, to approve the Annual Development Plan and budget.

The Trustees are responsible for setting general policy, adopting an annual plan and budget, approving the statutory accounts, monitoring the Academy by the use of budgets and other data, and making major decisions about the direction of the Academy, capital expenditure and staff appointments. In addition, the trustees monitor and review safeguarding procedures.

The Trustees and Board of Trustees have devolved responsibility for day-to-day management of the Trust to the Chief Executive Officer and Senior Leadership Team (SLT). The SLT comprises the Chief Executive Officer and the Heads of School. The SLT implements the policies laid down by the Trustees and report back to them on performance.

The Chief Executive Officer is the Accounting Officer.

Arrangements for setting pay and remuneration of key management personnel

The Trustees consider the Board of Trustees and the senior leadership team comprise the key management personnel of the Academy in charge of directing and controlling, running, and operating the Trust on a day to day basis. All Trustees give their time freely and no Trustee received remuneration in the year.

Details of Trustees' expenses and related party transactions are disclosed in the notes to the accounts.

The pay of key management personnel is reviewed annually, and nationally negotiated pay rates (Teachers and NJC terms and conditions) are adhered to for all remuneration, including those of senior leaders.

Trade union facility time

There were no relevant union officials for the year ended 31 August 2022.

Related Parties and other Connected Charities and Organisations

Pilton Bluecoat Academy has historic collaborative links with Pilton Infants' as a feeder school, Pilton Academy and Pathfield Special School, which together form the Pilton Association of Schools. Along with this, the school plays an active part within the Barnstaple Local Learning Community. Brayford and Umberleigh schools are within the South Molton Learning Community and their historic links with other local schools through this community, continue to be developed. Witheridge and High Bickington Academies both continue their relationship with the Two Moors Learning Partnership Co-operative Trust and Chulmleigh Local Learning Community. Beaford Academy joined the trust in June 2022 and continues to maintain good relationship with the Torrington Learning Community.

TEAM continues to benefit from its membership to the South West Institute for Teaching (SWIFT) which provides access to an extensive range of programmes, from Teacher Training, the Early Career Framework, and their Appropriate Body support for Early Career Teachers, through to Specialist and Leadership NPQs and a wide range of high quality CPD covering all aspects of professional development.

During the academic year our schools continued to work with the British Council and schools around the world. Pilton Bluecoat Academy, Umberleigh Academy and High Bickington Academy have been working with three schools from Mangalore, India on Connecting Classroom project.

Witheridge Academy have continued their partnership with Sanjivani International School in Mumbai, India. The work completed by the two schools has been recognised by the British Council with both schools being awarded with the International Schools Award (Full Accreditation).

Pilton Bluecoat Academy successfully gained funding to take part in an Erasmus project with schools in Italy, Croatia, Turkey and Portugal. The Official Title of the Project is 'Education Accessed with Games'. Activities were focused on looking at how to integrate games-based learning into schools by taking into consideration

the potential of the countries in this field, by exchanging good practices and observing and examining the applications on site, and integrating them into each setting. Teachers from Pilton Bluecoat have visited Turkey, Croatia and Portugal this year with a reciprocal visit arranged for European teachers in the autumn term 2022.

TEAM Multi-Academy Trust has continued to work with and support Amigos International a local NGO working in Uganda. The charity itself works with children, youths and caregivers facilitating training, education and infrastructure so that they may become self-supporting in the future.

There are no related parties which either control or significantly influence the decisions and operations of TEAM Multi Academy Trust. There are no sponsors or formal Parent Teacher Associations associated with the Academies.

OBJECTIVES AND ACTIVITIES

Objects and Aims

The principal object and activity of the Trust is to advance for the public benefit education in the United Kingdom. We achieve this through our vision of 'Life, Love and Learning to the Full,' where we aim to ensure that our pupils receive a world-class education at every stage of their schooling. All Trust schools are well maintained, well managed and provide welcoming environments where our children and staff understand how precious life is and what it means to be loved.

The principal object and activity of the Charitable Company is the operation of TEAM Multi-Academy Trust to provide free education and care for pupils of different abilities. The Academy's specialism is primary education.

The aims of the Academy during the 2021-2022 academic year ended 31 August 2021 are summarised below:

- to continue to raise the standard of educational attainment and achievement of all pupils.
- to provide a broad and balanced curriculum, including extra-curricular activities.
- to develop students as more effective learners.
- to develop school sites so that it enables students to achieve their full potential.
- to ensure that every child enjoys the same high-quality education in terms of resourcing, tuition and care.
- to improve the effectiveness of the Academy by keeping the curriculum and organisational structure under continual review.
- to provide value for money for the funds expended.
- to develop the curriculum at all our primary schools ensuring that the foundation subjects are brought up to the same level as the core subjects.
- to develop greater coherence, clarity, and effectiveness in school systems.
- to comply with all appropriate statutory and curriculum requirements.
- to conduct the Academy's business in accordance with the highest standards of integrity, probity and openness.
- to maintain collaborate and develop partnerships with local primary schools
- to continue developing international partnerships with schools in India and Europe.
- to continue to work closely with schools and external agencies to ensure the trust successfully negotiates its way through the Covid-19 pandemic.

At TEAM Multi-Academy Trust our approach is built on four drivers: Building Learning Power, Building Futures, Building Community and Building Self-Esteem & Positive Mental Wellbeing. It is through the drivers that we seek to raise aspirations by providing our children with the skills, knowledge and understanding required to realise their ambitions. Our curriculum provides the children with a wide range of experiences and provides opportunities for them to develop a sense of pride in their locality whilst at the same time helping them to learn about other cultures from around the world. Learning is rich, exciting and diverse, but most

STRATEGIC REPORT

Achievements and performance

Purpose and Direction

TEAM Multi-Academy Trust's strategic aim is to rapidly become established as a dynamic Trust which is capable of building on its success, extending its influence and making county-wide contributions in improving outcomes for young people.

Despite the continued interruptions related to Covid-19 illness and absence our schools continued to function efficiently. Additional capacity within the Trust was fully utilised to ensure that when Covid-related staff absence occurred in each school the children still received a full curriculum offer. Catch-up programmes took place and schools worked incredibly hard to ensure the most vulnerable children and their families were well supported throughout the year. Educational visits took place, as did a full array of residential visits and Trust wide sporting events. Due to the reduction of Covid restrictions each school was also able to offer an increased amount of community events.

Two of our schools, Witheridge Academy and High Bickington Academy were inspected under the new Ofsted Education Inspection Framework during the Autumn term of 2021. High Bickington had a Section 5 inspection and moved from Requires Improvement (2016) to Good. Witheridge had a Section 8 inspection and was assessed as being Good. The support provided by the Trust was highlighted during feedback at both of the inspections. Evidence of this can also be found in each inspection report.

The school improvement cycle was successfully implemented across the academic year. Each school received six visits from the School Improvement Team (SIP) and CEO. After the visits further, ongoing support was agreed upon with each individual school as required. Visits highlighted that teaching was consistently good or better. In addition, an external School Improvement Advisor was employed to carry out a review of the quality of education provided by each school setting. Please see below for further information regarding each school's Ofsted grading.

At TEAM Multi-Academy Trust the safety of pupils and staff is of utmost importance. Robust systems and structures are in place to ensure that everyone feels safe and supported. The Implementation and effectiveness of the Child Protection and Safeguarding policy which conforms to the latest DfE guidance were monitored regularly throughout the year. Evidence of this can be found in the termly safeguarding reports to Trustees and through the school Improvement visit notes.

Curriculum and Assessment

A significant amount of work took place across the Trust to ensure that each school had a curriculum that was fit for purpose, ambitious and inspired its pupils. The two Ofsted Inspection reports along with reports from external school improvement advisors provide evidence of the work completed within this area by members of SLT, subject specialists and curriculum teams.

'Leaders are determined that all pupils will succeed. The school's ambitious curriculum inspires pupils to rise to leaders' high expectations. Consequently, pupils' attitudes to their learning are strong, from the early years to Year 6.' (High Bickington Academy Ofsted Report, October 2021)

'The school has drawn effectively on expertise from trust leaders to improve the curriculum and develop teachers' skills in most subjects. Subject leaders have benefited from focused support from the trust curriculum leaders to plan the content and sequencing of the curriculum well.' (High Bickington Academy Ofsted Report, October 2021)

'Leaders ensure that pupils get the best education possible. Staff share these high expectations across the curriculum, subject leaders have given great thought to how to sequence learning so that pupils know more and remember more. They have considered carefully how new knowledge builds on what pupils have previously learned. Educational trips, such as visiting mining communities in Wales, bring the curriculum alive. Trust leaders guide subject leaders and colleagues in this important work. Consequently, the curriculum is suitably ambitious across the full range of subjects.' (Witheridge Ofsted Report, September 2021)

During the month of May, for the first time since 2019 schools administered SATs tests. The overall Trust percentages are listed below:

As always, our schools ensured that the children were given plenty of support to reduce anxiety in the weeks leading up to the tests. Data outcomes for each school were shared with the Standards and Scrutiny committee in July and analysis was completed into how Covid-19 has impacted the children over the past few years.

Assessment data showed that bullying, homophobic and racial incidents observed in the schools were rare and swiftly acted upon. Pupil voice activities were used to gather the children's views on a broad range of themes linked to Behaviour and Attitudes. Analysis of the July 2022 pupil voice questionnaires highlighted that child from across the Trust felt safe and enjoyed their learning. There were 2 Fixed Term Exclusions, one at Umberleigh Academy and one at Witheridge Academy. Both of these were related to SEBD and put children and staff at risk. There were no Fixed Term Exclusions in any of our other settings. There were no Permanent Exclusions.

Teaching and Learning

School Improvement reviews of each school took place at the end of each half term and highlighted that overall teachers demonstrated good knowledge and understanding of the subjects they teach. They used questioning effectively and demonstrated ways pupils think about subject content.

Schools continued to work on the development of live modelling and providing children with immediate, precise feedback. Training on this was provided by specialists within the Trust. Observations carried out by

the School Improvement Team, the external SIP advisor and Ofsted highlighted strengths within this area of teaching and learning.

Support for our most vulnerable pupils across the Trust was very good and evidence for this can be found in the Witheridge and High Bickington Ofsted reports and external review records.

'Leaders, including the special educational needs coordinator (SENCo), have a secure understanding of the needs of pupils with special educational needs and/or disabilities (SEND). Pupils with SEND enjoy an appropriately ambitious curriculum. Staff identify pupils' needs quickly and support them well in lessons. As a result of some thoughtful adjustments, most pupils with SEND are becoming increasingly successful.' (High Bickington Academy Ofsted Report, October 2021)

The MAT continued to invest in the SEN and Inclusion team by employing an additional pastoral worker to work across some of the more rural settings.

All Trust schools present calm and orderly working environments resulting in effective learning for pupils. There are clear routines and expectations for the behaviour of pupils across all aspects of school life.

Learning behaviours observed in class were very good and children work well collaboratively and support each other. Effective behaviour management strategies ensure that the impact of pupils with challenging behaviours are limited and do not affect the learning of others. Children are respectful, polite and show a willingness to want to improve.

Investing In and Developing Others

TEAM's Initial Teacher Training programme which is being run in partnership with the University of Exeter, went from strength to strength during 2021-2022. The Trust successfully delivered the training and the monitoring of the mentor/teacher relationships in their placements across ten North Devon primary schools. Nine trainees were recruited for the academic year with seven completing the course. Unfortunately, one trainee left the course on the second day and one asked to defer to the following year on medical grounds. 100% of the trainees who completed the training went on to find full time employment in education on completion of their course.

The University of Exeter has recognised TEAM's excellent provision for trainee teachers and as a result of this, the curriculum devised by TEAM is being used as the exemplar curriculum for all other Devon Lead Schools. The Trust will be continuing with the ITT programme during the academic year 2022 to 2023.

Along with the ITT programme the Trust has continued to increase the amount of CPD opportunities for school leaders, teachers and support staff. Some examples are listed below:

- Trust wide INSET days focused on development priorities were held.
- TEAM Safeguarding CPD with Babcock LPD.
- Three Trust wide CPD sessions were held with Ed Pawson (Diocese Education Advisor). One was attended by teachers and the other two by the RE leads, Senior Leaders and governors.
- MAT wide training events for teaching assistants at High Bickington Academy.
- A teaching assistant exchange programme was set up so individuals could visit their partner school to observe practice and exchange ideas.
- Members of staff accessing the NPQH and NPQLBC training programmes.
- Teachers from across the Trust were involved in the Jurassic Maths project which is focused on the development of teaching and learning in maths.
- Teachers have worked alongside lead artists, photographers and filmmakers for the 'Voice to tell our story' Beaford Arts and University of South Wales research project.
- Curriculum teams continued to meet on a termly basis focusing on activities linked to school improvement.

Facing Outwards

As the academic year progressed, the Trust continued to collaborate and develop partnerships with schools in North Devon and further afield. Internationally our work continued with schools in Asia, Africa and Europe. Witheridge Academy gained the British Council International Schools Award for their partnership work with Sanjivani International School in Mumbai, India. Our other schools have continued to work with Lourdes Central School in Mangalore, India. Along with this, the staff of Pilton Bluecoat Academy recently completed visits to Portugal as their European project work with five schools continues to flourish. Moving forward, further British Council visits have been planned to schools in Croatia and Turkey.

The Trust has continued to work closely with a range of other partners across the academic year. School leaders, teachers and curriculum teams engaged in a range of CPD opportunities with the Diocese of Exeter and the South West Institute for Teaching (SWIFT). Senior Leaders and central team members also attended the South West Trust Leaders network briefings organised by the RSC.

At TEAM Multi-Academy Trust our growth strategy is centred on schools working in collaboration to ensure sustainable improvement. Our growth model is focused on capacity, ensuring that the MAT has the internal capacity, both within the central team and our partner schools, to effect positive change in supporting all schools to become excellent educational communities. TEAM MAT has grown over the past twelve months to increase the number of academies from 5 to 6. The following academy joined the Trust during the 2020/21 academic year:

- Beaford Community Primary and Nursery School joined the MAT on the 1st of June 2022

Along with this, the Trust continued to work in a management partnership agreement with Pilton Infants'.

Developing the Organisation

The MAT continued to invest in its IT infrastructure, connectivity and hardware. In response to the IT audit completed at the start of the year teacher laptops were purchased where needed. I-3 interactive whiteboard panels were bought for each rural setting. In order to build on the 2020-2021 investment into Chromebooks it was decided that purchasing a small set of I-Pads for each EYFS would help to support with teaching and learning. All TEAM schools were involved in the Beaford Arts 'Voice to tell our Story,' project and as a result of this a class set of Go Pro cameras and webcams were purchased to aid with the film-making work. Funds were also allocated to upgrade the Wi-Fi connectivity in some of our settings. Visualisers were also purchased for each school to support the Trust improvement priority linked to the development of live modelling/scaffolding and providing children with precise, high quality feedback.

New websites were designed and constructed for the MAT, Pilton Bluecoat, Witheridge, High Bickington, Umberleigh, Brayford and Beaford. These all went live early in July. A professional photographer was also employed to take photographs for each website.

TEAM Multi-Academy Trust strengthened the board during the academic year, with one new trustee joining. The new Trustee brings with her extensive experience in education with particular strengths in safeguarding and senior leadership. The Board is now seeking to recruit trustees and develop further in order to serve the needs derived from the continued growth of the MAT.

Finance

Overall, the Trust has robust systems in place to ensure financial compliance is strong and there is a strong focus on finance across all areas of the Trust. Staffing is carefully reviewed, and future needs assessed, with the Trust utilising temporary contracts, when possible, for example, when the staffing relates to funding streams that may be removed or end or where there might be uncertainty over numbers. Class sizes are calculated, and affordability reviewed. Consideration is given to factors such as numbers of pupil premium pupils and numbers of pupils with EHCP plans. Draft modelling is undertaken, and all areas of the budget are

interrogated to ensure a balanced position is achieved. If this is not the case and reserves are to be utilised, this would be taken to the Finance Committee to initially review.

The Trust was successful in obtaining funding through a Capital Investment Fund bid and as a result of this new external aluminium windows and doors were successfully fitted to Pilton Bluecoat Academy during the academic year. The funding obtained for this project was £332,000. All properties around the MAT are well maintained and in good working order.

Overall, the Trust is in a sound financial position with healthy reserves of income predicted at the end of this year. The Trust applies prudent financial management when setting its annual budgets for all the schools and undertakes forecasting, which can often take a perhaps cautious approach on occasion.

Key Performance Indicators

The main financial performance indicator is the level of reserves held at the Balance Sheet date. In particular, the management of spending against General Annual Grant (GAG) requires special attention. In the period under review, £13,526 was carried forward representing 0.5% of GAG income.

As funding is based on pupil numbers this is also a key performance indicator.

Another key financial performance indicator is staffing costs as a percentage of GAG. For 2022 this was 127%, compared to 116% in 2021.

Going Concern

After making appropriate enquiries, the Board of Trustees has a reasonable expectation that the Academy Trust has adequate resources to continue in operational existence for the foreseeable future. For this reason it continues to adopt the going concern basis in preparing the financial statements. Further details regarding the adoption of the going concern basis can be found in the Statement of Accounting Policies.

FINANCIAL REVIEW

Most of the Trust's income is obtained from the DfE via the ESFA in the form of recurrent grants, the use of which is restricted to particular purposes. The grants received from the DfE during the year ended 31 August 2022 and the associated expenditure are shown as Restricted Funds in the Statement of Financial Activities.

The Trust also receives grants for fixed assets from the DfE which are shown in the Statement of Financial Activities as restricted income in the Fixed Asset Fund. The Restricted Fixed Asset Fund balance is reduced by annual depreciation charges over the useful life of the assets concerned, as defined in the Trust's accounting policies.

During the year ended 31 August 2022, the Academy received total income of £5,763,989 and incurred total expenditure of £4,632,586. The excess of income over expenditure for the year was £1,131,403.

At 31 August 2022 the net book value of fixed assets was £2,992,880 and movements in tangible fixed assets are shown in note 15 to the financial statements. The assets were used exclusively for providing education and the associated support services to the pupils of the Academy.

There has been a decision taken by the DfE that the value of land and buildings which belong to the Diocese should not be included as assets of the Trust. This relates to land and buildings at Pilton Bluecoat, High Bickington and Witheridge Church Academies.

The Trust has taken on the deficit in the Local Government Pension Scheme in respect of its non-teaching staff transferred on conversion. The deficit is incorporated within the Statement of Financial Activity with details in Note 24 to the financial statements.

Key financial policies adopted or reviewed during the year include the Finance Policy which lays out the framework for financial management, including financial responsibilities of the Board, Chief Executive Officer, budget holders and other staff, as well as delegated authority for spending.

Reserves Policy

The Trustees review the reserve levels of the Academy annually. This review encompasses the nature of income and expenditure streams, the need to match income with commitments and the nature of reserves. The Trustees take into consideration the future plans of the Academy, the uncertainty over future income streams and other key risks identified during the risk review.

The Trustees have determined that the appropriate level of free reserves should be approximately one month's expenditure, which based on 2022 figures is £320,760 (excluding pension and depreciation costs). The reason for this is to provide sufficient working capital to cover delays between spending and receipt of grants and to provide a cushion to deal with unexpected emergencies such as urgent maintenance. Total reserves of the trust amount to £3,824,256 (excluding the defined benefit pension liability), although £3,048,551 of this is invested in fixed assets or represents non GAG-restricted funds. The remaining £775,705 (representing £554,885 unrestricted funds and £13,526 unspent GAG) is the balance that the Trustees monitor in accordance with the Board's reserves policy. This represents 2 months of normal recurring expenditure.

The defined benefit pension scheme reserve has a negative balance. The effect of the deficit position of the pension scheme is that the Academy Trust is paying higher employers' pension contributions over a period of years. The higher employers' pension contributions will be met from the Academy Trust's budgeted annual income. Whilst the deficit will not be immediately eliminated, there should be no actual cash flow deficit on the fund, nor any direct impact on the free reserves of the Academy Trust.

Investment Policy

Trustees are committed to ensuring that all funds under their control are managed in such a way as to maximise return whilst minimising risk. Any cash not required for operating expenses is placed on deposit at the most favourable rate available from providers covered by the Financial Services Compensation Scheme. Day to day management of the surplus funds is delegated to the Chief Executive Officer and Trust Business Manager within strict guidelines approved by the Board of Trustees

PRINCIPAL RISKS AND UNCERTAINTIES

The Board of Trustees has reviewed the major risks to which the Academy Trust is exposed together with the operating, financial and compliance controls that have been implemented to mitigate those risks.

The principal risks and uncertainties facing the Academy are as follows:

Financial - the Academy has considerable reliance on continued Government funding through the ESFA. In the last year 62% of the Academy's incoming resources were ultimately Government funded and whilst this level is expected to continue, there is no assurance that Government policy or practice will remain the same or that public funding will continue at the same levels or on the same terms.

Failures in governance and/or management - the risk in this area arises from potential failure to effectively manage the Academy's finances, internal controls, compliance with regulations and legislation, statutory returns, etc. The Trustees continue to review and ensure that appropriate measures are in place to mitigate these risks.

Reputational - the continuing success of the Trust is dependent on continuing to attract applicants in sufficient numbers by maintaining the highest educational standards. To mitigate this risk Trustees, ensure that student success and achievement are closely monitored and reviewed.

Safeguarding and child protection - the Trustees continue to ensure that the highest standards are maintained in the areas of selection and monitoring of staff, the operation of child protection policies and procedures, health & safety and discipline. The Trustees have enhanced the risk register to ensure due consideration is given to the continued provision of a safe learning environment for pupils during a pandemic

Staffing - the success of the Trust is reliant upon the quality of its staff and so the Trustees monitor and review policies and procedures to ensure continued development and training of staff as well as ensuring there is clear succession planning.

Fraud and mismanagement of funds - The Trust has appointed an internal auditor to carry out checks on financial systems and records as required by the Academy Handbook. All finance staff receive training to keep them up to date with financial practice requirements and develop their skills in this area.

The Academy has continued to strengthen its risk management process throughout the year by improving the process and ensuring staff awareness. A risk register is maintained and reviewed and updated on a regular basis.

Whilst the Trust's pupil numbers remain stable, risks to revenue funding from a falling roll are small. The stability of pupil numbers in the smaller rural schools continues to be paramount in the future viability of each school. This is particularly relevant to Brayford Academy where intake is low and numbers on roll have dropped. The National Funding Formula is not yet fully implemented and with the increasing employment costs budgets will continue to be tight in coming years.

The Board of Trustees recognises that the defined benefit pension scheme deficit (Local Government Pension Scheme), which is set out in Note 24 to the financial statements, represents a significant potential liability. However, as the Trustees consider that the Academy is able to meet its known annual contribution commitments for the foreseeable future, this risk from this liability is minimised.

Fundraising

All fund raising is undertaken by the relevant parent support group pertinent to each Academy. The Trustees are mindful that each of these groups are operating in accordance with current legislation and recognised standards and this is monitored by the Heads of Schools and the Trust Business Manager. Fundraising will always be undertaken as part of a community activity as community cohesion is a priority ahead of any additional income stream.

Plans for future periods

The Academy will continue to strive to provide outstanding education and improve the levels of performance of its pupils at all levels. The Academy will continue to aim to attract high quality teachers and support staff in order to deliver its objectives.

The Academy will continue to work with partner schools to improve the educational opportunities for students in the wider community.

Scope of responsibility

Review of value for money

As Accounting Officer the Chief Executive Officer has responsibility for ensuring that the Academy Trust delivers good value in the use of public resources. The purpose of the system of internal control

The risk and control framework

The Academy Trust's system of internal financial control is based on a framework of regular management information and administrative procedures including the segregation of duties and a system of delegation and accountability. In particular it includes:

- Comprehensive budgeting and monitoring systems with an annual budget and periodic financial reports which are reviewed and agreed by the Board of Trustees
- Regular reviews by the Audit and Finance Committee of reports which indicate financial performance against the forecasts and of major purchase plans, capital works and expenditure programmes
- Setting targets to measure financial and other performance
- Clearly defined purchasing (assets purchase or capital investment) guidelines
- Delegation of authority and segregation of duties
- Identification and management of risks

The Board of Trustees has considered the need for a specific internal audit function and has decided:

The key laws and regulations we considered in this context included the Academies Accounts Direction, Academies Financial Handbook, UK Companies Act and tax legislation.

In addition, we considered provisions of FRS 102 and Charity SORP that do not have a direct effect on the financial statements but compliance with which may be fundamental to the Academy Trust's ability to operate or to avoid a material penalty. These included safeguarding regulations, data protection regulations, occupational health and safety regulations, education and inspections legislation, building legislation and employment legislation.

1. ACCOUNTING POLICIES

A summary of the principal accounting policies adopted (which have been applied consistently, except where noted), judgments and key sources of estimation uncertainty, is set out below.

1.1 BASIS OF PREPARATION OF FINANCIAL STATEMENTS

The financial statements of the Academy Trust, which is a public benefit entity under FRS 102, have been prepared under the historic cost convention in accordance with the Financial Reporting Standard Applicable in the UK and Republic of Ireland (FRS 102), the Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (Charities SORP (FRS 102)), the Academies Accounts Direction 2021 to 2022 issued by ESFA, the Charities Act 2011 and the Companies Act 2006.

1.2 GOING CONCERN

The Trustees assess whether the use of going concern is appropriate i.e. whether there are any material uncertainties related to events or conditions that may cast significant doubt on the ability of the Academy Trust to continue as a going concern. The Trustees make this assessment in respect of a period of at least one year from the date of authorisation for issue of the financial statements and have concluded that the Academy Trust has adequate resources to continue in operational existence for the foreseeable future and there are no material uncertainties about the Academy Trust's ability to continue as a going concern, thus they continue to adopt the going concern basis of accounting in preparing the financial statements.

1. ACCOUNTING POLICIES (continued)

1.3 INCOME

All incoming resources are recognised when the Academy has entitlement to the funds, the receipt is probable and the amount can be measured reliably.

Grants are included in the Statement of Financial Activities on a receivable basis. The balance of income received for specific purposes but not expended during the period is shown in the relevant funds on the Balance Sheet. Where income is received in advance of meeting any performance-related conditions there is not unconditional entitlement to the income and its recognition is deferred and included in creditors as deferred income until the performance-related conditions are met. Where entitlement occurs before income is received, the income is accrued.

General Annual Grant is recognised in full in the Statement of Financial Activities in the year for which it is receivable and any abatement in respect of the period is deducted from income and recognised as a liability.

Capital grants are recognised in full when there is an unconditional entitlement to the grant. Unspent amounts of capital grant are reflected in the Balance Sheet in the restricted fixed asset fund. Capital grants are recognised when there is entitlement and are not deferred over the life of the asset on which they are expended.

Sponsorship income provided to the Academy which amounts to a donation is recognised in the Statement of Financial Activities in the period in which it is receivable (where there are no performance-related conditions), where the receipt is probable and it can be measured reliably.

Donations are recognised on a receivable basis (where there are no performance-related conditions) where the receipt is probable and the amount can be reliably measured.

Other income, including the hire of facilities, is recognised in the year it is receivable and to the extent the Academy Trust has provided the goods or services.

Where assets and liabilities are received by the Academy Trust on conversion to an Academy, the transferred assets are measured at fair value and recognised in the Balance Sheet at the point when the risks and rewards of ownership pass to the Academy Trust. An equal amount of income is recognised as a transfer on conversion within 'Income from Donations and Capital Grants' to the net assets received.

- **Transfer on conversion**

Where assets and liabilities are received by the Academy Trust on conversion to an academy, the transferred assets are measured at fair value and recognised in the Balance sheet at the point when the risks and rewards of ownership pass to the Academy Trust. An equal amount of income is recognised as a transfer on conversion within 'Income from Donations and Capital Grants' to the net assets received.

1.4 INTEREST RECEIVABLE

Interest on funds held on deposit is included when receivable and the amount can be measured reliably by the Academy Trust; this is normally upon notification of the interest paid or payable by the institution with whom the funds are deposited.

1.5 EXPENDITURE

1. ACCOUNTING POLICIES (continued)

Expenditure is recognised once there is a legal or constructive obligation to transfer economic benefit to a third party, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is classified by activity. The costs of each activity are made up of the total of direct costs and shared costs, including support costs involved in undertaking each activity. Direct costs attributable to a single activity are allocated directly to that activity. Shared costs which contribute to more than one activity and support costs which are not attributable to a single activity are apportioned between those activities on a basis consistent with the use of resources. Central staff costs are allocated on the basis of time spent, and depreciation charges allocated on the portion of the asset's use.

- **Charitable activities**

These are costs incurred on the Academy Trust's educational operations, including support costs and costs relating to the governance of the Academy Trust apportioned to charitable activities.

- **Grants payable**

These are charged in the year when the offer is made except in those cases where the offer is conditional, such grants being recognised as expenditure when the conditions attaching are fulfilled. Grants offered subject to conditions which have not been met at the year end are noted as a commitment, but not accrued as expenditure.

Grants Payable represent the cost of building improvement works to property owned by the Diocese and occupied by the Academy Trust for school use.

All resources expended are inclusive of irrecoverable VAT.

1.6 TANGIBLE FIXED ASSETS

Assets costing £1,000 or more are capitalised as tangible fixed assets and are carried at cost, net of depreciation and any provision for impairment.

Where tangible fixed assets have been acquired with the aid of specific grants, either from the government or from the private sector, they are included in the Balance sheet at cost and depreciated over their expected useful economic life. Where there are specific conditions attached to the funding requiring the continued use of the asset, the related grants are credited to a restricted fixed asset fund in the Statement of financial activities and carried forward in the Balance sheet. Depreciation on the relevant assets is charged directly to the restricted fixed asset fund in the Statement of financial activities. Where tangible fixed assets have been acquired with unrestricted funds, depreciation on such assets is charged to the unrestricted fund.

On conversion the Academy Trust was granted a 125 year lease from the Local Authority for the land and buildings previously occupied by the local authority schools. On conversion the long term leasehold property was recognised as a donation from the Local Authority and was valued using the depreciated replacement cost method.

1. ACCOUNTING POLICIES (continued)

1.6 TANGIBLE FIXED ASSETS (CONTINUED)

Depreciation is provided on all tangible fixed assets other than freehold land and assets under construction, at rates calculated to write off the cost of each asset on a straight-line basis over its expected useful life, as follows:

Freehold property	- 2% straight line
Long-term leasehold property	- 2% straight line
Furniture and fixtures	- 10% straight line
Computer equipment	- 33% straight line
Motor vehicles	- 20% straight line

A review for impairment of a fixed asset is carried out if events or changes in circumstances indicate that the carrying value of any fixed asset may not be recoverable. Shortfalls between the carrying value of fixed assets and their recoverable amounts are recognised as impairments. Impairment losses are recognised in the Statement of financial activities.

The Academy Trust has been granted use of the school buildings for Pilton Bluecoat Church of England Junior School, High Bickington C of E Primary Academy and Witheridge C of E Primary Academy from the Diocese of Exeter under Supplemental Agreements which grant the Academy Trust a license to occupy the land and buildings. The Academies Accounts Direction prescribes that under this agreement the risks and rewards of ownership remain with the Diocese.

The Academy Trust's occupation for the period is recognisable as a notional donation (since it pays no actual rent) and a notional rental expense for its use of the premises. The value of the donation is the amount that the Academy Trust would otherwise have to pay to secure premises for its operations and is based on the rateable value of the buildings.

Capital improvements to the Diocesan property occupied by the Academy Trust are recognised as grant expenditure.

1.7 DEBTORS

Trade and other debtors with no stated interest rate and due within one year are recorded at the amount of the cash or other consideration expected to be received. Prepayments are valued at the amount paid.

1.8 CASH AT BANK AND IN HAND

Cash at bank and in hand includes cash and short term highly liquid investments with a short maturity of three months or less from the date of acquisition or opening of the deposit or similar account and cash on deposit that has a notice period of less than 30 days.

1.9 LIABILITIES

Liabilities are recognised when there is an obligation at the Balance sheet date as a result of a past event, it is probable that a transfer of economic benefit will be required in settlement, and the amount of the settlement can be estimated reliably. Liabilities are recognised at the amount that the Academy Trust anticipates it will pay to settle the debt or the amount it has received as advanced payments for the goods or services it must provide.

1. ACCOUNTING POLICIES (continued)

1.10 FINANCIAL INSTRUMENTS

The Academy Trust only holds basic financial instruments as defined in FRS 102. The financial assets and financial liabilities of the Academy Trust and their measurement bases are as follows:

Financial assets - trade and other debtors are basic financial instruments and are debt instruments measured at amortised cost as detailed in note 16. Prepayments are not financial instruments. Cash at bank is classified as a basic financial instrument and is measured at face value.

Cash at bank is classified as a basic financial instrument and is measured at face value.

Financial liabilities - trade creditors, accruals and other creditors are financial instruments, and are measured at amortised cost as detailed in note 17. Taxation and social security are not included in the financial instruments disclosure definition. Deferred income is not deemed to be a financial liability, as the cash settlement has already taken place and there is an obligation to deliver services rather than cash or another financial instrument.

1.11 TAXATION

The Academy Trust is considered to pass the tests set out in Paragraph 1 Schedule 6 of the Finance Act 2010 and therefore it meets the definition of a charitable company for UK corporation tax purposes.

Accordingly, the Academy Trust is potentially exempt from taxation in respect of income or capital gains received within categories covered by Part 11, chapter 3 of the Corporation Tax Act 2010 or Section 256 of the Taxation of Chargeable Gains Act 1992, to the extent that such income or gains are applied exclusively to charitable purposes.

1. ACCOUNTING POLICIES (continued)

1.12 PENSIONS

Retirement benefits to employees of the Academy Trust are provided by the Teachers' Pension Scheme ("TPS") and the Local Government Pension Scheme ("LGPS"). These are defined benefit schemes.

The TPS is an unfunded scheme and contributions are calculated so as to spread the cost of pensions over employees' working lives with the Academy Trust in such a way that the pension cost is a substantially level percentage of current and future pensionable payroll. The contributions are determined by the Government Actuary on the basis of quadrennial valuations using a prospective unit credit method. TPS is an unfunded multi-employer scheme with no underlying assets to assign between employers. Consequently, the TPS is treated as a defined contribution scheme for accounting purposes and the contributions recognised in the period to which they relate.

The LGPS is a funded multi-employer scheme and the assets are held separately from those of the Academy Trust in separate trustee administered funds. Pension scheme assets are measured at fair value and liabilities are measured on an actuarial basis using the projected unit credit method and discounted at a rate equivalent to the current rate of return on a high quality corporate bond of equivalent term and currency to the liabilities. The actuarial valuations are obtained at least triennially and are updated at each Balance sheet date. The amounts charged to operating surplus are the current service costs and the costs of scheme introductions, benefit changes, settlements and curtailments. They are included as part of staff costs as incurred. Net interest on the net defined benefit liability/asset is also recognised in the Statement of financial activities and comprises the interest cost on the defined benefit obligation and interest income on the scheme assets, calculated by multiplying the fair value of the scheme assets at the beginning of the period by the rate used to discount the benefit obligations. The difference between the interest income on the scheme assets and the actual return on the scheme assets is recognised in other recognised gains and losses.

Actuarial gains and losses are recognised immediately in other recognised gains and losses.

1.13 OPERATING LEASES

Rentals paid under operating leases are charged to the Statement of financial activities on a straight line basis over the lease term.

1.14 FUND ACCOUNTING

Unrestricted income funds represent those resources which may be used towards meeting any of the charitable objects of the Academy Trust at the discretion of the Trustees.

Restricted fixed asset funds are resources which are to be applied to specific capital purposes imposed by the funders where the asset acquired or created is held for a specific purpose.

Restricted general funds comprise all other restricted funds received with restrictions imposed by the funder/donor and include grants from the Department for Education Group.

Transfers are made between restricted funds and restricted fixed asset funds where restricted funds are used to purchase fixed assets and where restricted fixed asset funds are used on non-capital expenditure on church owned properties.

2. CRITICAL ACCOUNTING ESTIMATES AND AREAS OF JUDGMENT

Estimates and judgments are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

Critical accounting estimates and assumptions:

The Academy Trust trust makes estimates and assumptions concerning the future. The resulting accounting estimates and assumptions will, by definition, seldom equal the related actual results. The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are discussed below.

The present value of the Local Government Pension Scheme defined benefit liability depends on a number of factors that are determined on an actuarial basis using a variety of assumptions. The assumptions used in determining the net cost or income for pensions include the discount rate. Any changes in these assumptions, which are disclosed in note 25, will impact the carrying amount of the pension liability. Furthermore a roll forward approach which projects results from the latest full actuarial valuation performed at 31 March 2019 has been used by the actuary in valuing the pensions liability at 31 August 2022. Any differences between the figures derived from the roll forward approach and a full actuarial valuation would impact on the carrying amount of the pension liability.

Critical areas of judgment:

The Academy Trust obtains use of fixed assets as a lessee. The classification of such leases as operating or finance lease requires the Academy Trust to determine, based on an evaluation of the terms and conditions of the arrangements, whether it retains or acquires the significant risks and rewards of ownership of these assets and accordingly whether the lease requires an asset and liability to be recognised in the Balance Sheet.

Unrestricted funds - Funds freely available for general purposes.

Nursery funds - Funds generated by the nursery operations.

RESTRICTED FUNDS

General Annual Grant (GAG) - Income from the ESFA which is to be used for the normal running costs of the Academy, including education and support costs.

High Needs - Funding received by the Local Authority to fund further support for students with additional needs.

Pupil Premium - Pupil premium represents funding received from the ESFA for children that qualify for free school meals to enable the Academy to address the current underlying inequalities between those children and their wealthier peers.

UIFSM - Universal Infant Free School Meals represents funding received from the ESFA to provide school meals to underprivileged children.

Educational visits - This is income from parents and guardians to contribute toward the costs of school

trips and visits during the year.

Teacher Pay & Pension - Funding from the ESFA to contribute towards teacher salary costs.

PE Grant – This represents funding received from the ESFA and must be used to fund improvements to the provision of PE and sport, for the benefit of primary-aged pupils, so that they develop healthy lifestyles.

COVID Catch Up - Income from the government to help pupils and disadvantaged young people catch up on missed education because of COVID 19.

Other restricted income - This funding represents other income that has been received with specific restrictions on its expenditure, in particular Universal Infant Free School Meals and the rates grant.

Diocesan property rental - The Academy Trust's occupation of property owned by the Diocese of Exeter for the period is recognisable as a notional donation and a notional rental expense.

Condition improvement fund - government funding to address significant condition need, keeping education provider buildings safe and in good working order.

Pension reserve – This represents the Academy Trust's share of the assets and liabilities in the Local Government Pension Scheme. As with most pension schemes this is currently in deficit due to an excess of scheme liabilities over scheme assets which was inherited on conversion to an Academy Trust. The Academy Trust is following the recommendations of the actuary to reduce the deficit by making additional contributions over a number of years.

RESTRICTED FIXED ASSET FUNDS

Fixed assets transferred from the LA on conversion – This represents the fixed assets transferred from the Local Authority on conversion to an Academy Trust.

Fixed assets purchased from GAG and other restricted funds - This represents the net book value of assets purchased using restricted non-capital incoming resources.

DfE/ESFA Capital Grants - These funds are received for direct expenditure on fixed asset projects. The fixed asset fund balance at the year end represents the NBV of assets and any unspent grant amounts.

Other Local Authority funding - This represents funding received from the Local Authority to purchase small capital items.

Other capital donations - This includes donations provided by the local and wider community for capital improvements made to the Schools.

Transfers in/out - The transfer between the restricted funds and the restricted fixed asset funds represents GAG funding used to purchase fixed assets.

OTHER INFORMATION

Under the funding agreement with the Secretary of State, the Academy Trust was not subject to a limit on the amount of GAG it could carry forward at 31 August 2022.

25. PENSION COMMITMENTS

The Academy Trust's employees belong to two principal pension schemes: the Teachers' Pension Scheme England and Wales (TPS) for academic and related staff; and the Local Government Pension Scheme (LGPS) for non-teaching staff, which is managed by Devon County Council. Both are multi-employer defined benefit schemes.

The latest actuarial valuation of the TPS related to the period ended 31 March 2016 and of the LGPS 31 March 2019.

Contributions amounting to £100,218 were payable to the schemes at 31 August 2022 (2021 - £78,778) and are included within creditors.

TEACHERS' PENSION SCHEME

The Teachers' Pension Scheme (TPS) is a statutory, contributory, defined benefit scheme, governed by the Teachers' Pension Scheme Regulations 2014. Membership is automatic for full-time teachers in academies. All teachers have the option to opt-out of the TPS following enrolment.

The TPS is an unfunded scheme to which both the member and employer makes contributions, as a percentage of salary - these contributions are credited to the Exchequer. Retirement and other pension benefits are paid by public funds provided by Parliament.

VALUATION OF THE TEACHERS' PENSION SCHEME

The Government Actuary, using normal actuarial principles, conducts a formal actuarial review of the TPS in accordance with the Public Service Pensions (Valuations and Employer Cost Cap) Directions 2014 published by HM Treasury every 4 years. The aim of the review is to specify the level of future contributions. Actuarial scheme valuations are dependent on assumptions about the value of future costs, design of benefits and many other factors. The latest actuarial valuation of the TPS was carried out as at 31 March 2016. The valuation report was published by the Department for Education on 5 March 2019. The key elements of the valuation and subsequent consultation are:

- employer contribution rates set at 23.68% of pensionable pay (including a 0.08% administration levy)
- total scheme liabilities (pensions currently in payment and the estimated cost of future benefits) for service to the effective date of £218,100 million and notional assets (estimated future contributions together with the notional investments held at the valuation date) of £196,100 million, giving a notional past service deficit of £22,000 million
- the SCAPE rate, set by HMT, is used to determine the notional investment return. The current SCAPE rate is 2.4% above the rate of CPI, assumed real rate of return is 2.4% in excess of prices and 2% in excess of earnings. The rate of real earnings growth is assumed to be 2.2%. The assumed nominal rate of return including earnings growth is 4.45%.

The next valuation result is due to be implemented from 1 April 2023.

The employer's pension costs paid to TPS in the year amounted to £303,538 (2021 - £247,063).

Under the definitions set out in FRS 102, the TPS is an unfunded multi-employer pension scheme. The Academy Trust has accounted for its contributions to the scheme as if it were a defined contribution scheme. The Academy Trust has set out above the information available on the scheme.

LOCAL GOVERNMENT PENSION SCHEME

The LGPS is a funded defined benefit pension scheme, with the assets held in separate trustee-administered funds. The total contribution made for the year ended 31 August 2022 was £241,000 (2021 - £214,000), of which employer's contributions totalled £188,000 (2021 - £167,000) and employees' contributions totalled £ 53,000 (2021 - £47,000). The agreed contribution rates for future years are 17.6 per cent for employers and 5.5 - 12.5 per cent for employees.

As described in note 24 the LGPS obligation relates to the employees of the Academy Trust, who were the employees transferred as part of the conversion from the maintained school and new employees who were eligible to, and did, join the Scheme in the year. The obligation in respect of employees who transferred on conversion represents their cumulative service at both the predecessor school and the Academy Trust at the balance sheet date.

Parliament has agreed, at the request of the Secretary of State for Education, to a guarantee that, in the event of academy closure, outstanding Local Government Pension Scheme liabilities would be met by the Department for Education. The guarantee came into force on 18 July 2013.
